The Director of the Division of Waste Management and Radiation Control (Director) is proposing to enter into Stipulation and Consent Order No. 2212143 with Clean Harbors Environmental Services, Inc. (CHES) to resolve Notice of Violation and Compliance Order No. 2201008 without further administrative or judicial proceedings. CHES would pay a monetary penalty of \$20,040.00, while \$20,040.00 will be held in abeyance if CHES completes requirements set forth in Paragraph 12 of the Stipulation and Consent Order.

A 30-day public comment period to receive comments on proposed Stipulation and Consent Order No. 2212143 will commence on Thursday, November 2, 2023, and end at 5 p.m. on Friday, December 1, 2023.
