Proposed Stipulation and Consent Order with Clean Harbors Aragonite, LLC UTD 981 552 177

The Division of Waste Management and Radiation Control (DWMRC) is proposing to enter into a Stipulation and Consent Order (SCO) with Clean Harbors Aragonite, LLC. (CHA) to resolve a notice of Violation (NOV) issued on April 8, 2020.

A 30-day public comment period to receive comments on the proposed SCO will commence on Monday, June 7, 2021 and end at 5 p.m. on Tuesday, July 6, 2021.
