The Division of Waste Management and Radiation Control (DWMRC) is proposing to amend Stipulation and Consent Order (SCO) Number 2106050 with Clean Harbors Aragonite, LLC. (CHA) to extend the timeframe to complete the Supplemental Environmental Project (SEP) contained therein.

A 30-day public comment period to receive comments on the amendment to SCO No. 2106050 will commence on Monday, November 7, 2022, and end at 5 p.m. on Tuesday, December 6, 2022.
