## NOTICE OF PUBLIC COMMENT Grassy Mountain Facility, LLC – Class 3 Permit Modification Request UTD 991301748

The Director of the Division of Waste Management and Radiation Control is seeking public comment on a Class 3 Permit Modification Request that would allow the Grassy Mountain Facility to build a new surface impoundment and six hazardous waste landfill cells. This Notice of Public Comment replaces the Notice published in the November 6, 2018 edition of this paper. The modification request and supporting documentation has been reviewed and a draft of the affected portions of the permit and supporting documentation has been prepared.

The public comment period to receive comments on the permit modification will commence on December 4, 2018 and will end on January 21, 2019. The public hearing that was scheduled for December 5, 2018 has been rescheduled to 6:00 p.m. on Wednesday, January 9, 2019, in the Commission Chambers (Room 321) in the Tooele County Building, located at 47 South Main Street, Tooele, Utah.
