## Public Notice and Request for Comment

The United States Environmental Protection Agency (EPA) Region 8 hereby provides notice and solicits comments from interested persons regarding EPA's proposal to issue a TSCA/RCRA Coordinated Approval for land disposal of Polychlorinated Biphenyls (PCB) wastes at Landfill Cell 8, which has been authorized under the State-Issued Part B Permit. Approval is sought by the applicant under TSCA Section 6(e)(1) and the implementing regulations for PCBs 40 C.F.R. Part 761. The Approval is being sought by Clean Harbors Grassy Mountain, LLC, Exit 41 Off I-80 3 Miles East, Grassy Mountain, Utah, P.O. Box 2275, Salt Lake City, Utah 84122.

**Public Comment Period:** The comment period will open Monday, February 8, 2021, and close on Wednesday, March 10, 2021. During the comment period, any interested person may submit written comments concerning the Application or the Draft Approval. A person may request an extension of the comment period or a virtual public hearing. The requested extension or hearing must be submitted in writing within the first fifteen (15) calendar days of the comment period. The request for a hearing shall state the nature of the issues proposed to be raised in the hearing.
