### Amendment 27 to Radioactive Material License No. UT 2300249 Energy Solutions, LLC, Clive, Tooele County, Utah

The Director of the Division of Waste Management and Radiation Control (Division) is requesting public comment regarding a proposed Licensing Action to revise the Energy *Solutions* '(Licensee) Low Level Radioactive Waste Radioactive Material License (RML) UT 2300249 for the Clive facilities near Clive, Tooele County, Utah.

A 45-day public comment period to receive comments on the proposed Licensing Action will commence on Thursday, March 2, 2023, and end at 5 p.m. on Friday, April 17, 2023. A public hearing has been scheduled from 4:00 pm to 5:00 pm on Thursday, March 23, 2023, at the DEQ Board Room, Room 1015, at the Department of Environmental Quality, 195 North 1950 West, Salt Lake City Utah.
