The Director of the Division of Waste Management and Radiation Control is proposing to enter into STIPULATION AND CONSENT ORDER (SCO) Number **2102006** with Thatcher Company, Inc. to resolve issues identified in Thatcher's November 26, 2019, Self-Disclosure Letter and provide direction on continued work necessary to address those issues and put procedures in place to prevent recurrence.

A 30-day public comment period to receive comments on the SCO will commence on October 18, 2021 and end at 5 p.m. on November 16, 2021.
