The Director of the Division of Waste Management and Radiation Control invites comment from the public on a draft Site Management Plan (SMP) developed by Hafers 1388 Properties LC. The SMP includes activity use limitations and future actions needed to manage the soil and groundwater contamination present at the former Six States Distributors located at 1388 South 300 West, Salt Lake City, Utah. The property is also required to implement an Environmental Covenant that will be recorded in the Salt Lake County Recorder's Office, after approval of the SMP.

A 30-day public comment period to receive comments on the SMP will commence on February 7, 2022, and end at 5 p.m. on March 8, 2022.
