A Site Management Plan (SMP) for Red Hanger Cleaners in Millcreek, Utah has been submitted to the Department of Waste Management and Radiation Control. The SMP outlines methods and actions that will be taken to mitigate risk and manage exposures at the site from former spills of tetrachloroethylene (PCE).

A 30-day public comment period to receive comments on the Site Management Plan will commence on Monday, August 8, 2022 and end at 5 p.m. on Tuesday, September 6, 2022.
