The Director of the Division of Waste Management and Radiation Control invites comment from the public on a draft Site Management Plan (SMP) developed for Opus Green Townhomes Property. The SMP includes activity use limitations and future actions needed to manage the soil and groundwater contamination present near the Former Morgan-Hanauer Smelter at 4186 South Main Street, Millcreek, Utah. The property is also required to implement an Environmental Covenant that will be recorded in the Salt Lake County Recorder's Office, after approval of the SMP.

A 30-day public comment period to receive comments on the will commence on Monday, September 12, 2022 and end at 5 p.m. on Tuesday, October 11, 2022.

All documents included in comments must be submitted in pdf format or as ASCII (text) files.
