NOTICE OF PUBLIC COMMENT ON Draft Renewal Permit

Iron County Parowan Class IVb Landfill

Iron County has submitted a permit renewal application to continue to operate its Class IVb landfill in Parowan, Iron County, Utah. The landfill will continue to receive non-hazardous construction and demolition solid waste. The renewal permit application has been reviewed by the Division of Waste Management and Radiation Control for compliance with the Solid Waste Management Rules and a draft permit has been prepared by the Director of Waste Management and Radiation Control. The Director is soliciting comments on the permit renewal application and the draft permit in relation to their compliance with the Solid Waste Management Rules. R315-311-3 of the Utah Administrative Code provides for a public comment period to receive comments on the renewal application and draft permit prior to final action by the Director.

The public comment period to receive comments on the draft permit will commence on February 2, 2021 and will end on March 3, 2021.

Under Utah Code Section 19-1-301.5 a person who wishes to challenge a Permit Order may only raise an issue or argument during an adjudicatory proceeding that was raised during the public comment period and was supported with sufficient information or documentation to enable the director to fully consider the substance and significance of the issue.
