The Division of Waste Management and Radiation Control (Division) has received and reviewed the *Wonsit Class IIIb Landfill Permit Modification* dated January 25, 2021 (DSHW-2021-001828). This Permit Modification will allow RNI to create an Exploration and Production Waste disposal cell from the former Pond 6 produced water evaporation pond.

The Division has reviewed the permit modification request and has found that the proposal is consistent with the existing boundaries, construction design, and all other aspects contained in the plan of operations approved under Permit 1302. The proposal is hereby approved as a minor modification.

Enclosed is a revised cover page for Permit 1302, which expires on October 15, 2023. Representatives of the Division of Waste Management and Radiation Control and the Tri-County Health Department will conduct periodic inspections of the landfill to assess compliance with the Permit and the Solid Waste Permitting and Management Rules.

Pursuant to the provisions of the *Utah Solid and Hazardous Waste Act*, Title 19, Chapter 6, Part 1, Utah Code Annotated (Utah Code Ann.) (the Act) and the *Utah Solid Waste Permitting and Management Rules*, Utah Administrative Code R315-301 through 320 adopted thereunder, a Permit is issued to

R.N. Industries  
(Permittee)

to own, construct, and operate the RNI Wonsit Class IIIb Oil and Gas Exploration and Production Waste Landfill located in SE ¼ of Section 26; NE 1/4 Section of 35, Township 8 South, Range 21 East, Salt Lake Base and Meridian, Uintah County, Utah as shown in the Permit Application that was determined complete on July 10, 2013, Document Number 2013-003732.

By acceptance of this Permit, the Permittee agrees to be subject to the requirements of R315-301 through 320 of the Utah Administrative Code, as set forth herein and the conditions set forth herein.


All references to R315-301 through 320 of the Utah Administrative Code are to regulations that are in effect on the date this Permit becomes effective.
