## PUBLIC NOTICE AND COMMENT on Bayview Landfill Permit

Northern Utah Environmental Resource Agency submitted a permit application to renew the permit for the Bayview Landfill (a Class I Landfill) near Elberta, Utah. The proposed permit application has been reviewed and has been determined to be complete and in compliance with the Utah Solid Waste Permitting and Management Rules. The permit allows the facility to continue to operate the Bayview Landfill for ten years after the final permit has been approved. The Director of the Division of Waste Management and Radiation Control is currently seeking public comment on the draft Permit.

The public comment period to receive comments on the Permit draft will commence on February 2, 2021 and end on March 3, 2021.
