ATK Launch Systems - Promontory Landfill (Renewal)

ATK Launch Systems has applied for a permit renewal for their existing ATK Launch Systems - Promontory Landfill located at 9160 North Hwy. 83, Corinne UT, Box Elder County. The Permit renewal application was received by the Division of Waste Management and Radiation Control on April 2, 2021 (DSHW-2021-005283). The application was found to be complete and in compliance with the existing rules and regulations of the Utah Code and the Utah Administrative Rules. A draft permit has been prepared and the Director is now seeking public comment on the draft permit.

A 30-day public comment period to receive comments on the permit renewal will commence on August 26, 2021 and end at 5 p.m. on September 24, 2021.
