Tooele County Ibapah Class IVb Landfill

Tooele County has submitted a permit renewal application for their Class IVb Landfill located in Ibapah, Tooele County. This landfill accepts only non-hazardous construction/demolition waste for disposal. A municipal household waste (MSW) transfer container is also onsite. This MSW waste is regularly transferred to the Wasatch Regional Landfill for disposal. The Division of Waste Management and Radiation Control has reviewed the permit renewal documents and has prepared a draft permit.

A 30-day public comment period to receive comments on the draft renewal permit will commence on Monday, October 17, 2022, and end at 5 p.m. on Tuesday, November 15, 2022.

Under Utah Code Section 19-1-301.5 a person who wishes to challenge a Permit Order may only raise an issue or argument during an adjudicatory proceeding that was raised during the public comment period and was supported with sufficient information or documentation to enable the director to fully consider the substance and significance of the issue.
