NOTICE OF PUBLIC COMMENT ON
Cedar City – Bulloch Pit Class IVb Solid Waste Landfill

Cedar City has submitted a permit renewal application to continue to operate its Class IVb Landfill in Cedar City, Iron County. The landfill will continue to receive non-hazardous construction and demolition solid waste. The renewal permit application has been reviewed by the Division of Waste Management and Radiation Control for compliance with the Solid Waste Management Rules and a draft permit has been prepared. The Director is soliciting comments on the permit renewal application and the draft permit in relation to their compliance with the Solid Waste Management Rules. R315-311-3 of the Utah Administrative Code provides for a public comment period to receive comments on the renewal application and draft permit prior to final action by the Director.

A 30-day public comment period to receive comments on the draft permit will commence on Monday, November 14, 2022, and will end at 5 p.m. on Tuesday, December 13, 2022.

All documents included in comments must be submitted in pdf format or as ASCII (text) files.

Under Utah Code Section 19-1-301.5 a person who wishes to challenge a Permit Order may only raise an issue or argument during an adjudicatory proceeding that was raised during the public comment period and was supported with sufficient information or documentation to enable the director to fully consider the substance and significance of the issue.
