The Director of the Division of Waste Management and Radiation Control invites comment from the public on a draft Site Management Plan (SMP) developed by RG IV, LLC for property located East of Sheep Lane and north of SR-112, Tooele, Utah. The SMP includes activity use limitations and future actions needed to manage groundwater contamination present at the property. The property is also required to implement an Environmental Covenant that will be recorded in the Salt Lake County Recorder's Office, after approval of the SMP.

The public comment period to receive comments on the draft SMP for the RG IV, LLC property will commence on December 30, 2020 and end on January 28, 2021.
