The Director of the Division of Waste Management and Radiation Control is proposing to enter into STIPULATION AND CONSENT ORDER (SCO) Number 2212140 with Tooele Army Depot South Area to resolve Notice of Violation (NOV) Number 2208088 issued to Tooele Army Depot South Area on September 1, 2022.

A 30-day public comment period to receive comments on the proposed Stipulation and Consent Order will commence on Thursday, May 18, 2023 and end at 5 p.m. on Tuesday, June 20, 2023.
