The Director of the Division of Waste Management and Radiation Control is proposing to enter into STIPULATION AND CONSENT ORDER Number 2006055 (SCO) with Tri State Oil Reclaimers, Inc (Tri State) to resolve Notice of Violation Number 2003041 (NOV) issued to Tri State on April 17, 2020 regarding used oil violations documented during a February 2, 2020 compliance evaluation inspection at Tri State's facility in Genola, Utah.

The public comment period to receive comments on the Tri State Oil Reclaimers SCO will commence on September 9, 2020 and end on, October 8, 2020.
