The Director of the Division of Waste Management and Radiation Control (Director) is proposing to enter into Stipulation and Consent Order No. 2111117 with Tri State Oil Reclaimers, Inc. (TSOR) to resolve Notice of Violation and Compliance Order No. 2111114 without further administrative or judicial proceedings. TSOR shall pay a penalty of \$44,245.00 (forty-four thousand two-hundred forty-five dollars) as follows: pay a monetary penalty of \$22,122.50 (twenty-two thousand one-hundred twenty-two dollars and fifty cents), while the remaining penalty amount, \$22,122.50 (twenty-two thousand one-hundred twenty-two dollars and fifty cents) will be deferred and waived by the Director if TSOR complies with the Orders set forth in paragraphs 10.2 and 10.3 of the Stipulation and Consent Order.

A 30-day public comment period to receive comments on the Proposed SCO #2111117 for Resolution of NOV #2111114 will commence on January 8, 2024, and end at 5:00 p.m. on February 7, 2024.

All documents included in comments must be submitted in pdf format or as ASCII (text) files.

Under Utah Code Section 19-1-301.5, a person who wishes to challenge a Permit Order may only raise an issue or argument during an adjudicatory proceeding that was raised during the public comment period and was supported with sufficient information or documentation to enable the director to fully consider the substance and significance of the issue.
