Washington County Landfill Facility Permit

Washington County Solid Waste Special District #1 submitted a permit application to renew its permit for the Washington County Landfill Facility (Landfill) in Washington, Utah. The proposed permit application has been reviewed and has been determined to be complete and in compliance with the Utah Solid Waste Permitting and Management Rules. The permit allows the Landfill to continue to operate for ten years after it has been approved. The Director of the Division of Waste Management and Radiation Control is currently seeking public comment on this draft permit.

A 30-day public comment period to receive comments on the draft permit will commence on January 31, 2022 and end at 5 p.m. on March 1, 2022.

All documents included in comments must be submitted in pdf format or as ASCII (text) files.

Under Utah Code Section 19-1-301.5 a person who wishes to challenge a Permit Order may only raise an issue or argument during an adjudicatory proceeding that was raised during the public comment period and was supported with sufficient information or documentation to enable the director to fully consider the substance and significance of the issue.
