## NOTICE OF PUBLIC COMMENT ON Renewal of Permit Long Valley Sanitary Landfill

The Western Kane County Special Service District #1 submitted a permit application to renew their permit to operate the Long Valley Sanitary Landfill (a Class II Landfill) located near Glendale, Utah in Kane County. The permit application has been reviewed and has been determined to be complete and in compliance with the Utah Solid Waste Permitting and Management Rules. The Permit allows the facility to continue to operate the Long Valley Sanitary Landfill for ten years after it has been approved. The Director of the Division of Waste Management and Radiation Control is seeking public comment on the Permit.

The public comment period to receive comments on the Permit renewal will commence on February 5, 2021 and end on March 8, 2021.

Under Utah Code Section 19-1-301.5, a person who wishes to challenge a Permit Order may only raise an issue or argument during an adjudicatory proceeding that was raised during the public comment period and was supported with sufficient information or documentation to enable the director to fully consider the substance and significance of the issue.
