NOTICE OF PUBLIC COMMENT ON

Draft Landfill Permit

Western Water Solutions – Sand Pass Oil and Gas Exploration and Production Waste Landfill

Western Water Solutions has submitted a permit application to operate the Sand Pass Oil and Gas Exploration and Production Waste Landfill, located at 200 West 10000 South, Myton, (Duchesne County) Utah 84052. Upon approval, this Oil and Gas Exploration and Production Waste Landfill will accept only oil and gas exploration and production waste.

The permit application has been reviewed by the Division of Waste Management and Radiation Control for compliance with the Solid Waste Management Rules and a draft permit has been prepared by the Director of the Division of Waste Management and Radiation Control. The Director is soliciting comments on the permit application and the draft permit in relation to their compliance with the Solid Waste Management Rules. R315-311-3 of the Utah Administrative Code provides for a public comment period to receive comments on the permit application and draft permit prior to final action by the Director.

The public comment period to receive comments on the draft permit will commence on July 15, 2020 and end on August 14, 2020.

Written comments will be accepted if received by 5:00 p.m. on August 14, 2020 and should be submitted to the address below.

Under Utah Code Section 19-1-301.5 a person who wishes to challenge a Permit Order may only raise an issue or argument during an adjudicatory proceeding that was raised during the public comment period and was supported with sufficient information or documentation to enable the director to fully consider the substance and significance of the issue.
