The exam rosters for each location are posted on our wastewater operator certification website under

"Exams" / "Rosters" as soon as the applications are processed. Check to be certain that you are scheduled for the specific type of exam and location you requested. The current version of the standardized treatment and collection exams now has 110 questions, which include 100 predetermined questions to be scored, plus 10 unidentified questions being pre-tested for future use.

Time allotted to take the exam is three (3) hours for either 100 or 110 question exams, in compliance with ABC's testing recommendations. No additional time is allowed if you choose to take more than one exam during a session. Cell phones may NOT be used as calculators.

Fee is \$100.00 per exam – checks payable to "Division of Water Quality" COST:

(Full refund up to the application deadline–after the deadline, no refunds can be given)

Submit a fully completed exam application, notarized Citizenship/Alien ID Certification

form with copy of photo ID (if not previously submitted), and the exam fee payable by cash, check, money order, or *credit/debit cards (on-line, or by appointment in person)*. Completed forms may be submitted by email to wwopcert@utah.gov if the fee has been
