# PURPOSE OF PUBLIC NOTICE

THE PURPOSE OF THIS PUBLIC NOTICE IS TO DECLARE THE INTENTION OF THE STATE OF UTAH TO ISSUE A UTAH POLLUTANT DISCHARGE ELIMINATION SYSTEM (UPDES) PERMIT UNDER THE AUTHORITY OF THE UTAH WATER POLLUTION CONTROL ACT, SECTION 19-5-104(9) AND 107(2), UTAH CODE ANNOTATED 1953, AS AMENDED. SAID "PERMIT" REFERS TO THE UPDES PERMIT AND THE STATEMENT OF BASIS.

### **BACKGROUND**

The process wastewater discharge will be from the ammonium nitrate reactor condensate and water wash scrubber. The water wash scrubber works as a regular gas scrubber but the solution in the scrubber is water that is not recycled in the scrubber and is directly discharge to the process waste system. The process waste water comes from the ammonium nitrate reactor as the reaction of ammonium nitrate produce nitrous oxide gas and water. The wastewater from the reactor must be treated due to the pH being less than 5 when it is discharged from the reactor.

After considering public comments the director may execute the permit reissuance, revise it or abandon it. The director will not publish a notice of decision provided the permit will be signed without any changes and no comments are received during the public comment period.
