BACKGROUND

Central Weber has modified its Pretreatment Local Limits and Rules and Regulations. The changes could impact industrial dischargers discharging to the Central Weber publicly owned treatment works.

A public hearing can be requested but must be filed during the 30 day comment period which will end on October 6, 2017. A request for a public hearing must be filed per the requirements of 40 CFR 403.11. After considering public comments the director may approve, revise or abandon the local limits and rules and regulations. The director will not publish a notice of decision provided the local limits and rules and regulations will be approved without any changes and no comments are received during the public comment period.
