Public notice of modification to Logan City Corporation's Legal Authority related to a Pretreatment Program delegated by the Division of Water Quality

PURPOSE OF PUBLIC NOTICE

THE PURPOSE OF THIS PUBLIC NOTICE IS TO SOLICIT PUBLIC COMMENT REGARDING LOGAN CITY'S INTENTION TO MODIFY ITS PRETREATMENT REGULATIONS REGARDING ITS LEGAL AUTHORITY TO IMPLEMENT THE PRETREATMENT PROGRAM. THE SEWER LEGAL AUTHORITY HAS BEEN REVIEWED BY THE DIVISION OF WATER QUALITY, ONCE THE PUBLIC NOTICE AND COMMENT PROCESS ARE COMPLETED; IT IS THE DIVISION OF WATER QUALITY'S INTENTION TO FORMALLY APPROVE THE MODIFICATIONS TO THE LOGAN CITY CORPORATION'S LEGAL AUTHORITY.

BACKGROUND

Logan City Corporation has modified its legal authority for the pretreatment program. The changes could impact industrial dischargers discharging to the Logan City Corporation's publicly owned treatment works.

A public hearing can be requested but must be filed during the 30 day comment period which will end on December 8, 2017. A request for a public hearing must be filed per the requirements of 40 CFR 403.11. After considering public comments the director may approve, revise or abandon the pretreatment legal authority. The director will not publish a notice of decision provided the pretreatment legal authority will be approved without any changes and no comments are received during the public comment period.
