**PURPOSE OF PUBLIC NOTICE**

The purpose of this public notice is to declare the State of Utah's intention to issue a Utah Pollutant Discharge Elimination System (UPDES) General Permit for Treated Ground Water under authority of the Utah Water Pollution Control Act, Section 19-5-104(9) and 107(2), Utah Code Annotated 1953, as amended,

**BACKGROUND**

SLC Icehouse Land JV, LP is requesting coverage under the UPDES General Permit for Treated Ground Water to discharge groundwater to the Great Salt Lake via the Drain on 400 N. Arsenic was identified in the permittee's Notice of Intent (NOI) as a pollutant within the groundwater. Arsenic is not included as a pollutant requiring sampling in the General Permit for Treated Ground Water. In order to ensure water quality is protected, the Utah Division of Water Quality (DWQ) is issuing this public notice to add arsenic sampling and an associated effluent limitation of 0.1 mg/L<sup>1</sup> to UTG790089.
