DIVISION OF WATER QUALITY UTAH DEPARTMENT OF ENVIRONMENTAL QUALITY PUBLIC NOTICE TO MODIFY AND REISSUE A UPDES PERMIT AND TO ISSUE A VARIANCE TO THE TBPEL IMPLEMENTATION REQUIREMENTS

PURPOSE OF PUBLIC NOTICE

The purpose of this public notice is to declare the state of Utah's intention to modify and reissue a Utah pollutant discharge elimination system (UPDES) permit under authority of the Utah Water Pollution Control Act, section 19-5-104(9) and 107(2), Utah Code 1953, as amended. Said "Permit" refers to the UPDES permit and the fact sheet statement of basis (including total maximum daily loads (TMDL's)) if applicable, as per section 303(d) of the Federal Clean Water Act (CWA)]. The purpose of this public notice is also to declare the State of Utah's intention to grant a variance to the implementation deadline for Technology Based Phosphorus Effluent Limit (TBPEL) compliance to North Davis Sewer District. Pursuant to UAC R317-1-3.3 and corresponding provisions of the Utah Water Quality Act.

BACKGROUND

North Davis Sewer District (North Davis) operates a Water Reclamation Facility which serves the municipalities of Clearfield, Clinton, Layton, Roy, Sunset, Syracuse and West Point; portions of unincorporated Davis and Weber Counties; Hill Air Force Base and the Freeport Center. The facility discharges to an unnamed ditch that flows to Farmington Bay which goes on to Gilbert Bay and the Great Salt Lake. As part of complying with the TBPEL rule North Davis will be adding a new outfall that will discharge directly to Gilbert Bay and the Great Salt Lake. Once active this will be the primary outfall discharging up to 34 MGD based on the capacity of the pumps. Anything above that flow will discharge from Outfall 001 to Farmington Bay. Currently the facility has a design flow of 35 MGD with a peak of 65 MGD, and a storm event peak of 102 MGD. North Davis serves a population of approximately 229,000. The permit includes Biosolids provisions.

PUBLIC COMMENTS

Public comments are invited any time prior to the deadline of the close of business on <u>May 3, 2021</u>. During the public comment period provided under R317-8-6.5, any interested person may submit written comments on the draft permit and may request a public hearing, if no hearing has already been scheduled. for a public hearing shall be in writing and shall state the nature of the issues proposed to be raised in the hearing. All comments will be considered in making the final decision and shall be answered as provided in R317-8-6.12. After considering public comment, the Division of Water Quality may reissue, revise, or abandon it.
