PUBLIC NOTICE TO REISSUE A UPDES PERMIT

PURPOSE OF PUBLIC NOTICE

THE PURPOSE OF THIS PUBLIC NOTICE IS TO DECLARE THE STATE OF UTAH'S INTENTION TO ISSUE A UTAH POLLUTANT DISCHARGE ELIMINATION SYSTEM (UPDES) PERMIT UNDER AUTHORITY OF THE UTAH WATER POLLUTION CONTROL ACT, SECTION 19-5-104(9) AND 107(2), UTAH CODE ANNOTATED 1953, AS AMENDED. SAID "PERMIT" REFERS TO THE UPDES PERMIT AND THE FACT SHEET STATEMENT OF BASIS (INCLUDING TOTAL MAXIMUM DAILY LOADS (TMDL'S)) IF APPLICABLE, AS PER SECTION 303(D) OF THE FEDERAL CLEAN WATER ACT (CWA)].

BACKGROUND

The facility serves the City of Provo with an average design flow of 21 MGD, and a design population equivalent of 160,000. The facility is located at 1685 South East Bay Boulevard in Provo City, Utah County, Utah, latitude 40° 12' 45" and longitude 111° 39' 00", with STORET Number 499656. Provo's wastewater treatment plant was originally constructed in 1954 and was upgraded in 1978 and 1988 and is currently undergoing an upgrade which will include the installation of a membrane bioreactor system and new process basins, associated piping and equipment, as well as the repurposing of the four existing aeration basins for equalization and surge storage.

PUBLIC COMMENTS

During the public comment period provided under *R317-8-6.5*, any interested person may submit written comments on the draft permit and may request a public hearing, if no hearing has already been scheduled. A request for a public hearing shall be in writing and shall state the nature of the issues proposed to be raised in the hearing. All comments will be considered in making the final decision and shall be answered as provided in *R317-8-6.12*. Public comments are invited any time prior to the deadline of the close of business on **May 17, 2021**.
