PUBLIC NOTICE OF ISSUANCE OF UPDES PERMIT

PURPOSE OF PUBLIC NOTICE

The purpose of this public notice is to declare the state of Utah's intention to issue a Utah Pollutant Discharge Elimination System (UDPES) Permit under the authority of the Utah Water Quality Act, Section 19-5-104 and 107, Utah Code Annotated 1953, as amended. Said "permit" refers to the UPDES Permit and the Fact Sheet and Statement of Basis (including the total maximum daily loads (TMDLs)) if applicable, as per Section 303 (d) of the Federal Clean Water Act (CWA).

BACKGROUND

This project is a temporary construction project to install new sewer utility pipelines for Salt Lake City. The new sewer line will be installed from the 1800 North/Chicago St. intersection along Chicago St. to a trenchless crossing under I-15 and the railroad and across Rosewood Park to 1200 West. This facility previously had a Treated Groundwater and Surface Water General Permit with the UPDES permit number of UTG790096. Given the total flow from the facility, the length of time of the project, and the nature of the water being discharged, the facility is being transitioned to an individual permit. The Antidegradation Review (ADR) is also going to Public Notice at this time.

PUBLIC COMMENTS

During the public comment period provided, under Utah Administrative Code (UAC) R317-8-6.5, any interested person may submit written comments on the draft permit and may request a public hearing if no hearing has already been scheduled. A request for a public hearing shall be in writing and shall state the nature of the issues proposed to be raised in the hearing. All comments will be considered in making the final decision and shall be answered as provided in UAC R317-8-6.12.
