Under Section 19-1-301.5, effective May 8, 2012, a person who wishes to challenge a Permit Order may only raise an issue or argument during an adjudicatory proceeding that was raised during the public comment period and was supported with sufficient information or documentation to enable the Director to fully consider the substance and significance of the issue. Wastewater from cell four of the lagoon treatment system is applied to crops grown on two nearby farm fields and evaporation wetlands using wheel-line irrigation systems. The permit requires Schreiber to follow an approved nutrient management plan to determine the amount of wastewater that is applied annually in a manner that will not cause surface or ground water contamination. Eleven ground water monitoring wells are used to monitor ground water quality to ensure that ground water and surface water are not being impacted by the land application activities.
