PURPOSE OF PUBLIC NOTICE

THE PURPOSE OF THIS PUBLIC NOTICE IS TO DECLARE THE STATE OF UTAH'S INTENTION TO MODIFY A UTAH POLLUTANT DISCHARGE ELIMINATION SYSTEM (UPDES) PERMIT UNDER AUTHORITY OF THE UTAH WATER QUALITY ACT, SECTION 19-5-104(9) AND 107(2), UTAH CODE 1953, AS AMENDED. SAID "PERMIT" REFERS TO THE UPDES PERMIT AND THE FACT SHEET STATEMENT OF BASIS (INCLUDING TOTAL MAXIMUM DAILY LOADS (TMDL'S)) IF APPLICABLE, AS PER SECTION 303(D) OF THE FEDERAL CLEAN WATER ACT (CWA)].

BACKGROUND

The Springdale Wastewater Lagoons serve the towns of Springdale and Rockville, as well as Zion National Park. The facility is located in Springdale, Washington County, Utah, with latitude 37°09'45" and longitude 113°04'17", and discharges to the Virgin River. The permit has been modified to update the Compliance Schedule for total suspended solids (TSS) and biological oxygen demand (BOD).

PUBLIC COMMENTS
