# **DESCRIPTION OF PERMIT MODIFICATION**

TSSD's 2020 Draft Permit and Fact Sheet Statement of Basis (FSSOB) were posted for Public Notice from April 14, 2020, to May 14, 2020. On May 13, 2020, the Utah Division of Water Quality (DWQ) received a comment submitted by TSSD in regards to the TDS limit and monitoring requirements in the draft documents. TSSD requested this limit be removed and monitoring reduced to monthly. This comment was discussed, RP was run using DWQ data, and, based on these results, TSSD's request was granted. The suggested changes open to comment are found below. Note these changes are to be incorporated into the draft permit and FSSOB.

The permit will incorporate the following changes:

Effluent Limitations and Monitoring Changes
