PUBLIC NOTICE OF MINOR MODIFICIATIONS TO GENERAL INDUSTRIAL STORM WATER PERMIT

PURPOSE OF PUBLIC NOTICE

THE PURPOSE OF THIS PUBLIC NOTICE IS TO DECLARE THE STATE OF UTAH'S INTENTION TO ISSUE MINOR MODIFICATIONS TO THE MULTI-SECTOR GENERAL PERMIT (MSGP) FOR STORM WATER DISCHARGES ASSOCIATED WITH INDUSTRIAL ACTIVITIES. THIS UTAH POLLUTANT DISCHARGE ELIMINATION SYSTEM (UPDES) PERMIT IS ISSUED UNDER THE AUTHORITY OF THE UTAH WATER QUALITY ACT, TITLE 9, CHAPTER 5, SECTION 104 AND 107. MODIFICATIONS ARE MADE IN ACCORDANCE WITH UTAH ADMINISTRATIVE CODE (UAC) R317-8-5.6(3).

PERMIT INFORMATION

NAME: MULTI-SECTOR GENERAL PERMIT (MSGP) FOR STORM WATER DISCHARGES ASSOCIATED WITH INDUSTRIAL ACTIVITIES UTR000000

BACKGROUND

This permit authorizes discharges of storm water from industrial sites as defined by 40 CFR § 122.26 (b)(14)(i-ix and x). It requires that a storm water pollution prevention plan be created which identifies personnel on the pollution prevention team, potential storm water pollution sources, management and structural controls to prevent storm water pollution, comprehensive site compliance evaluation results, and monitoring and reporting procedures for visual and sometimes analytical monitoring. A description of the modifications being made is contained in the fact sheet under "MODIFICATIONS MADE MAY 2020". Comments will only be accepted on permit provisions that have been modified. Per UAC R317-8-5.6(3), consent of the permittee is required for all minor modifications. If no comments are received during the 30 day public notice period then consent is assumed.

After considering public comment the Director may execute the permit or revise it.
