Utah commenced the triennial review of our water quality standards in January 2011 as required by Sec. 131.20 of the Clean Water Act. This review resulted in revisions to *UAC R317-2 Standards of Quality of Waters of the State* that are submitted for your approval. The following documents are provided for your review:


