### PUBLIC NOTICE OF PROPOSED AMENDMENTS TO UTAH ADMINISTRATIVE CODE R317-1, DEFINITIONS AND GENERAL REQUIREMENTS; R317-2, STANDARDS OF QUALITY FOR WATERS OF THE STATE

# PURPOSE OF PUBLIC NOTICE

The purpose of this public notice is to solicit public comment regarding the proposed amendments to Utah Administrative Code R317-1 Definitions and General Requirements and R317-2, Standards of Quality for Waters of the State. Amendments are proposed to the add nutrient criteria to headwater streams (Category 1 and 2) statewide, total dissolved solids criterion for Silver Creek (Summit County), Jordan River ammonia criteria (Salt Lake County , add the drinking water use to Sheep Creek (Cache County) and correct human health and aquatic life statewide criteria. ## BACKGROUND

The Utah Water Quality Board is considering amendments to Utah Administrative Code R317-2, Standards of Quality for Waters of the State. After considering the comments received, the Board may adopt the proposed changes, revise the changes prior to adoption, or may choose not to adopt the amendments. If the Board decides to revise the changes, a Change in Proposed Rule will be filed with the Utah Division of Administrative Rules and public noticed.
