PUBLIC NOTICE TO MODIFY A UPDES PERMIT

PURPOSE OF PUBLIC NOTICE

THE PURPOSE OF THIS PUBLIC NOTICE IS TO DECLARE THE STATE OF UTAH'S INTENTION TO MODIFY A UTAH POLLUTANT DISCHARGE ELIMINATION SYSTEM (UPDES) PERMIT UNDER AUTHORITY OF THE UTAH WATER POLLUTION CONTROL ACT, SECTION 19-5-104(9) AND 107(2), UTAH CODE ANNOTATED 1953, AS AMENDED. SAID "PERMIT" REFERS TO THE UPDES PERMIT AND THE FACT SHEET STATEMENT OF BASIS (INCLUDING TOTAL MAXIMUM DAILY LOADS (TMDL'S)) IF APPLICABLE, AS PER SECTION 303(D) OF THE FEDERAL CLEAN WATER ACT (CWA)].

BACKGROUND

Mayflower Mountain Resort is an all seasons resort to be constructed near Park City, Utah. The property was purchased in November of 2017 by BLX Mayflower LLC (Mayflower)– this property includes both inactive Mayflower and Star Mines, both of which still discharge into waters of the state, thus requiring a UPDES Permit. Mayflower was issued a UPDES permit on December 1, 2020. Included in this permit is a parameter limit of 5.0 mg/L daily minimum for dissolved oxygen (DO) for Outfall 001, sampled for compliance at latitude 40° 37' 15 " and longitude 111° 26' 15". Mayflower has requested a compliance point modification for DO. Currently, the DO sample is being collected in the Mayflower Mine discharge pipe, but if the modification is issued the DO sample will be collected at the end of the pipe, as it enters McHenry Creek. DWQ agrees with the requested sample collection location change on the basis that the modification would not negatively affect McHenry Creek, the receiving water. The DO parameter limit will not change, remaining at 5 mg/L for the daily minimum. The modification is outlined below.
