PURPOSE OF PUBLIC NOTICE

THE PURPOSE OF THIS PUBLIC NOTICE IS TO DECLARE THE STATE OF UTAH'S INTENTION TO MODIFY THE UTAH POLLUTANT DISHCARGE ELIMINATION SYSTEM (UPDES) CONCENTRATED AQUATIC ANIMAL PRODUCTION FACILITY GENERAL PERMIT (CAAPF), NO. UTG130000, UNDER AUTHORITY OF THE UTAH WATER QUALITY ACT, SECTION 19-5-104 AND 107, UTAH CODE ANNOTATED 1953, AS AMENDED. THIS NOTICE INCLUDES THE PROPOSED MODIFICATIONS TO THE CAAPF GENERAL PERMIT AND FACT SHEET STATEMENT OF BASIS (FSSOB) FOR THE PROPOSED CHANGES.

BACKGROUND

This permit modification, if implemented, will make changes to the CAAPF General Permit issued on April 6, 2020. The Federal Clean Water Act requires permitting of certain aquatic animal production facilities, such as fish hatcheries. Permit requirement is based on thresholds of the weight of fish produced each year or the weight of the feed fed per month to aquatic animals. The CAAPF General Permit is required by the aquatic animal production facilities that meet the permit thresholds, such as large fish hatcheries.

The CAAPF permit prohibits the use of copper pesticides by CAAPF operations. The presence of nuisance pests has become an issue in some areas of the State, so the permit is being modified to allow the application of copper pesticides for the treatment of nuisance pests, aquatic plants, and algae. Each facility that utilizes copper treatments will need to comply with the proposed permit modifications, included in this notice, that allow the use of copper-based pesticides.

During preparation of this proposed permit modification certain dates, spelling edits, table of contents changes, and minor language corrections may have been completed. Due to the nature of these changes, they were not considered major and are not required to be included in the public notice. These changes were made to improve readability and clarify the requirements of this permit. The vast majority of the permit remains unchanged from the CAAPF permit issued in April 2020.
