# DIVISION OF WATER QUALITY UTAH DEPARTMENT OF ENVIRONMENTAL QUALITY PUBLIC NOTICE OF A MODIFICATION OF A UPDES PERMIT

### PURPOSE OF PUBLIC NOTICE

The purpose of this public notice is to declare the State of Utah's intention to modify a Utah Pollution Discharge Elimination System (UPDES) Permit under authority of the Utah Water Pollution Control Act, Section 19-5-104(9) and 107(2), Utah Code Annotated 1953, as amended. Said "permit" refers to the UPDES Permit and the Fact Sheet Statement of Basis (including Total Maximum Daily Loads (TMDL's)) if applicable, as per Section 303(d) of the Federal Clean Water Act (CWA).

#### BACKGROUND

The Manti City Wastewater Treatment Facility (Manti) is located at 1500 N 100 E, Manti, Sanpete County, Utah. The design capacity is 0.33 MGD with maximum design capacity is 0.97 MGD, an average fiveyear flow of 0.29 MGD, and a population equivalent of 3,862 with 25 miles of sewer collection pipes. The facility consists of an influent pump station, influent 8-inch Parshall Flume, influent flow meter, grinder, bar screen, and three facultative lagoon cells totaling 41.5 acres. Cell #1 is 14.1 acres, cell #2 is 13.6 acres, cell #3 is 13.7 acres with chlorination for disinfection on the effluent. Manti's UPDES permit allows for discharge to the San Pitch River between October 1 and February 28 each calendar year. Currently, Manti does not have a pipeline to the San Pitch River. The facility holds the water in the lagoons during the winter months. During the summer, the water is piped to City owned property where it is reused to irrigate pasture. In the future, Manti will install a pipe to discharge into the San Pitch River.
