

## EPA PCS\_ICIS ECHO Search

The Permit Compliance System (PCS) and Integrated Compliance Information System (ICIS) databases provide information on companies which have been issued permits to discharge wastewater into rivers.

Utah DWQ's UPDES permit information is currently available in ICIS and includes all Individual UPDES Discharge Permits (Industrial and Municipal) and UPDES General Permits.

All of Utah's UPDES permit information is made available to the public through EPA's Enforcement and Compliance History Online (ECHO). The data on ECHO is refreshed weekly, typically on Saturday. For more information, visit the ECHO FAQs:

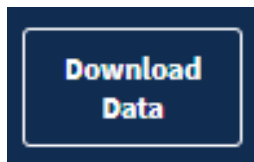
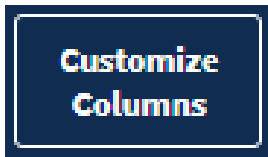
