# PURPOSE OF PUBLIC NOTICE

THE PURPOSE OF THIS PUBLIC NOTICE IS TO DECLARE THE STATE OF UTAH'S INTENTION TO MOIFY A UTAH POLLUTANT DISCHARGE ELIMINATION SYSTEM (UPDES) PERMIT UNDER AUTHORITY OF THE UTAH WATER QUALITY ACT, SECTION 19-5-104 AND 107, UTAH CODE ANNOTATED 1953, AS AMENDED. SAID "PERMIT" REFERS TO UPDES PERMIT AND THE STATEMENT OF BASIS (INCLUDING THE TOTAL MAXIMUM DAILY LOADS (TMDL'S)) IF APPLICABLE, AS PER SECTION 303 (d) OF THE FEDERAL CLEAN WATER ACT (CWA).

## **DESCRIPTION OF MODIFICATION**

Utah Administrative Code (UAC) Section R317-8-2.5 authorizes the issuance of general permits to categories of point sources within the same geographical area, which involve similar types of operations, discharge the same types of wastes, and require similar effluent limitations and pollution control measures. This general permit covers discharges of Concentrated Aquatic Animal Production Facilities (CAAPF) also known as fish hatcheries. This permit was recently renewed on April 10, 2020. During the renewal process the Kamas Fish Hatchery which had a load allocation in the Rockport/Echo Reservoir TMDL was inadvertently excluded from the table listing facilities that were subject to additional TMDL monitoring requirements. This modification will add these requirements to the permit.

The above is the only aspect of the Modified General Permit that is subject to public comment at this time.
