DIVISION OF WATER QUALITY UTAH DEPARTMENT OF ENVIRONMENTAL QUALITY PUBLIC NOTICE OF REISSUANCE OF GENERAL MULTI-SECTOR PERMIT FOR STORM WATER DISCHARGES ASSOCIATED WITH INDUSTRIAL ACTIVITY – GROUP 2

PURPOSE OF PUBLIC NOTICE

The purpose of this public notice is to declare the State of Utah's intention to issue a Utah Pollutant Discharge Elimination System (UPDES) permit under authority of the Utah Water Pollution Control Act, section 19-5-104(9) and 107(2), Utah Annotated Code 1953, as amended. Said "permit" refers to the UPDES permit and the fact sheet statement of basis (including Total Maximum Daily Loads (TMDLs)) if applicable, as per section 303(d) of the Federal Clean Water Act (CWA)].

PERMIT INFORMATION

NAME: MULTI-SECTOR GENERAL PERMIT (MSGP) FOR STORM WATER DISCHARGES ASSOCIATED WITH INDUSTRIAL ACTIVITIES PERMIT NO: UTR000000, GROUP 2-COVERING NDUSTRIAL SECTORS I, R, AB, AC

BACKGROUND

This section of the MSGP permit authorizes discharges of storm water from facilities that are primarily oil or gas facilities, ship or boat building facilities, facilities that manufacture transportation equipment, industrial or commercial machinery, and facilities that manufacture electronic and electrical equipment and components, photographic and optical goods (Sectors I, R, AB, and AC). Sectors I, R, AB, and AC includes facilities under standard industrial classification codes 13, 2911, 35, 36, 37, and 38.

The permit requires regulated industries to create a storm water pollution prevention plan for areas where storm water is exposed to industrial activities. Elements of this plan are required to include: 1. The development of a pollution prevention team; 2. Development of drainage maps and materials stockpiles; 3. An inventory of exposed materials; 4. Spill reporting and response procedures; 5. A preventative maintenance program; 6. Employee training; 7. Certification that storm water discharges are not mixed with non-storm water discharges; 8. Compliance site evaluations and potential pollutant source identification; 9. Visual examinations of storm water discharges.

After considering public comment the Division of Utah Water Quality may execute the permit issuance, revise it, or abandon it.
