Please find below the response that US Magnesium sent to the Army Corp. The process for the USACE is a little different than ours. They receive a completed application and place the application on public notice. This project was placed on public notice on August 2, 2022 and came off on September 2, 2022.

The permittee then is required to submit a response to comments which is the document I have included. Once USACE reviews the response to comments and deems them complete they will begin to complete an environmental assessment and then issue the final permit. I am reaching out to Michael Pectol who is the contact for the Great Salt Lake Region of Utah to find out where they are in the process. I will follow up once I hear back from him but I am assuming that since they just received the response to comments it will be a little while until they are finished with the environmental assessment.
